On 8-5-93, we reached intermediate casing point at 4340'. The next day, we set 4340' of 8 5/8", 32 ppf, J-55 intermediate casing in an 11" open hole. The casing was cemented to surface with the following cement slurries:

1450 sx LITE (35:65) + 6% gel + 15 lbs/sk salt + 1/4 lb/sk cellophane flakes
200 sx Class "C" + 2% CaCl2 + 1/4 lb/sk cellophane flakes

We circulated 218 sx of cement to the pit.
