We spud this new well on 7-31-93 at 1700 hrs (Nabors Drilling USA Rig #405). On 8-1-93, we set 870' of 13 3/8", 48 ppf, J-55 8rd casing in a 17 1/2" open hole. The casing was cemented with the following cement slurries:

500 sx LITE (35:65) + 6% gel + 2% CaCl2 + 1/4 lb/sk cellophane flakes
200 sx Class "C" + 2% CaCl2 + 1/4 lb/sk Cellophane flakes

We circulated 27 sx of cement to the pit. Estimated TOC = surface.
