On 8/15/93, we TD'd this well at 8412'. We set 8412' of 5 1/2" J-55, 15.5 and 17.0 ppf casing in a 7 7/8" open hole. The casing was cemented in two stages with a DV tool set at 5492'. We pumped the following cement slurries:

1st Stage = 475 sx Silica Lite (Class "H") + 3% salt + 0.1% fluid loss additive + 1/4 lb/sk cellophane flakes

2nd Stage = 150 sx LITE (35:65) + 6% gel + 1/4 lb/sk cellophane flakes
400 sx Class "C" + 4% gel + 1/4 lb/sk cellophane flakes

We did not circulate cement on either stage. A bond log will be run to determine the top of cement.
