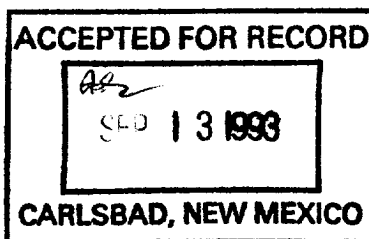

On 8/22/93, we set 4252' of 8 5/8" intermediate casing in an 11" open hole. The casing was cemented to surface with the following cement slurries:

1300 sx LITE (35:65) + 6% gel + 15 lb/sk salt + 1/4 lb/sk cellophane flakes
200 sx Class "C" + 2% CaCl₂ + 1/4 lb/sk cellophane flakes

We circulated 78 sx cement to the pit.

We spud this new well on 8-17-93 at 1530 hrs. The next day, we set 816' of 13 3/8" 48 ppf, H-40 surface casing in a 17 1/2" open hole. The casing was cemented to surface with the following cement systems:

500 sx LITE (35:65) + 6% gel + 2% CaCl2 + 1/4 lb/sk cellophane flakes
200 sx Class "C" + 2% CaCl2 + 1/4 lb/sk cellophane flakes

We circulated 140 sx of cement to the pit.
