7/16/93: Depth 570'. RU and ran 13 jts 13-3/8" 48# H-40 ST&C casing and set at 570'. Cemented w/ 500 sx "C" + 4% gel + 2% CaCl₂ + 1/4 pps Celloflake. Tail w/ 300 sx "C" + 2% CaCl₂. Plug down at 12:15 p.m. CST. Circ. 300 sx to pit. WOC.

7/17/93: WOC. Cut off and weld on head. Test to 600 psi. NU BOPs and choke manifold. Tested to 600 psi, ok. PU BHA and TIH. Test pipe, Hydril, and casing to 6000 psi, ok. WOC total of 24 hours. Resume drilling operations.
