8/4/93: Depth 4018'. RU and ran 89 jts 8-5/8" 32# J-55 & N-55 ST&C casing and set at 4018'. Cemented w/ 1250 sx "C" Lite containing 9 pps salt, 1/4 pps Celloflake. Tail w/ 500 sx "C" Neat w/ 2% CaCl₂. Plug down at 9:00 a.m. CDST. Circ'd 150 sx to pit. WOC. Cut off 8-5/8" casing and weld on 11" x 3M head. WOC.

8/5/93: NU and test BOPs, manifold, 3M Hydril to 1500 psi, ok. PU DC and TIH. Test casing to 1500 psi, ok. WOC total of 24 hours. Resume drilling operations.
