7/30/93: Spud 17-1/2" hole. Drilled to 600'. RU and ran 13 jts 13-3/8" 48# H-40 casing and set at 600'. Cemented w/ 500 sx Cl C + 4% gel, 2% A-7, & 1/4# sx CF. Tail w/ 300 sx Cl "C" + 2% A-7. Plug down at 5:15 p.m. CST. WOC. Circulated 300 sx to pit.

7/31/93: WOC. Cut off 13-3/8" casing and weld on head. NU BOP. Test BOP and choke manifold to 1500 psi, ok. TIH. Test casing and hydril to 1500 psi, ok. WOC total of 24 hours. Resume drilling operations.
