9/26/93: Depth 4220'. RU and ran 98 jts 8-5/8" 32# K-55 casing and set at 4220'. Cemented w/ 1400 sx "C"-Lite containing 9 pps salt and 1/4 pps Celloflake. Tail w/ 500 sx C1 "C" + 2% CaCl₂. Plug down at 9:30 a.m. GST. Circ'd 67 sx to pit. WOC 12 hours. Cut off 13-3/8" head.

9/27/93: Weld on head. NU and test BOPs and choke manifold, ok. PU BHA and TIH. WOC total of 24 hours. Test casing to 1500 psi, ok. Resume drilling operations.
