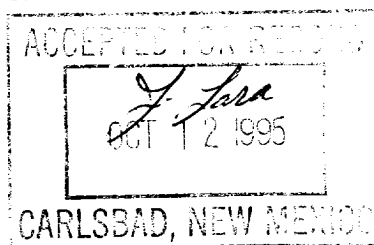

8/29/95: Spud 17-1/2" hole at 4:00 p.m. Drilling.

8/30/95: TD 17-1/2" hole at 401'. RU and ran 9 jts 13-3/8" 48.0# H-40 casing and set at 401'. Cemented w/ 425 sx C1 "C" + 2% CaCl2. Cement did not circulate. Plug down at 3:30 a.m. WOC. Run temp survey. TOC @ 97'. Redi-Mix backside w/ 8 yds. Cut csg off and weld on head. NU BOP's and test blind rams to 600 psi, ok.

8/31/95: PU BHA and RIH. Tagged cmt at 338'. Test pipe rams to 600 psi, ok. WOC total of 24 hours. Resumed drilling operations.
