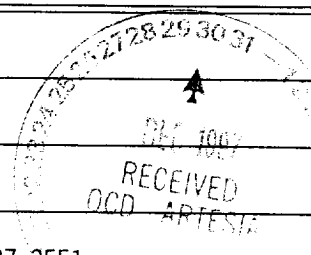

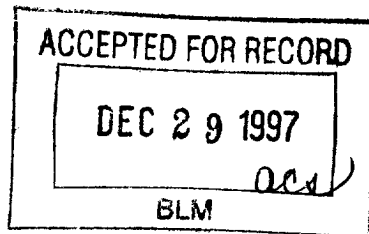

12/03/97: Spud 17-1/2" hole. Drlg.

12/04/97: Depth 350'. TD 17-1/2" hole. RU casing crew and ran 8 jts 13-3/8" 48# H-40 ST&C casing and set at 350'. Cemented w/ 200 sx Cl C + 6% gel, 1/4 pps Celloflake, & 2% CaCl2, tail in w/ 200 sx Cl C + 2% CaCl2. PD at 8:00 p.m. Circulated 77 sx to pit. WOC. Cut csg off and weld on head, tested weld to 600 psi, ok. Start NU BOP.

12/05/97: Nipple up BOP & choke. TIH and test casing to 600 psi, ok. WOC total of 17-1/2 hours. Resume drilling operations.
