



## DETAILS OF WORK

We propose to drill to a total depth of approximately 2400 feet with cable tools and complete in the Delaware formation. The casing program will be as follows:

3-5/8 inch 24#, H-40 surface casing to be set @ 100 feet. 4-1/2 inch casing set @ 2400 feet & cemented with 100 sacks cement. Casing program will be in accordance with USGS regulations.

I understand that this plan of work must receive approval in writing by the Geological Survey before operations may be commenced.


