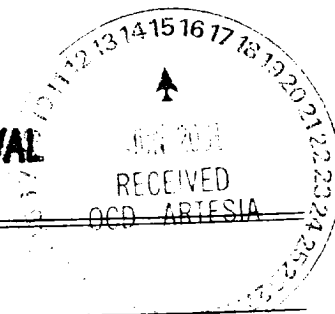
McKay Oil Corporation plans to drill this well as a horizontal well. The lateral to be drilled will enter the Abo formation approximately 400' North-Northwest of the vertical hole and will proceed in a North-Northwest direction for 3,000' to 3,500'.

We request permission to amend the casing program to allow McKay to set 5-1/2", J-55, 50.5' production casing to the point where the lateral enters the formation. The horizontal hole will be open hole for the length of the lateral.

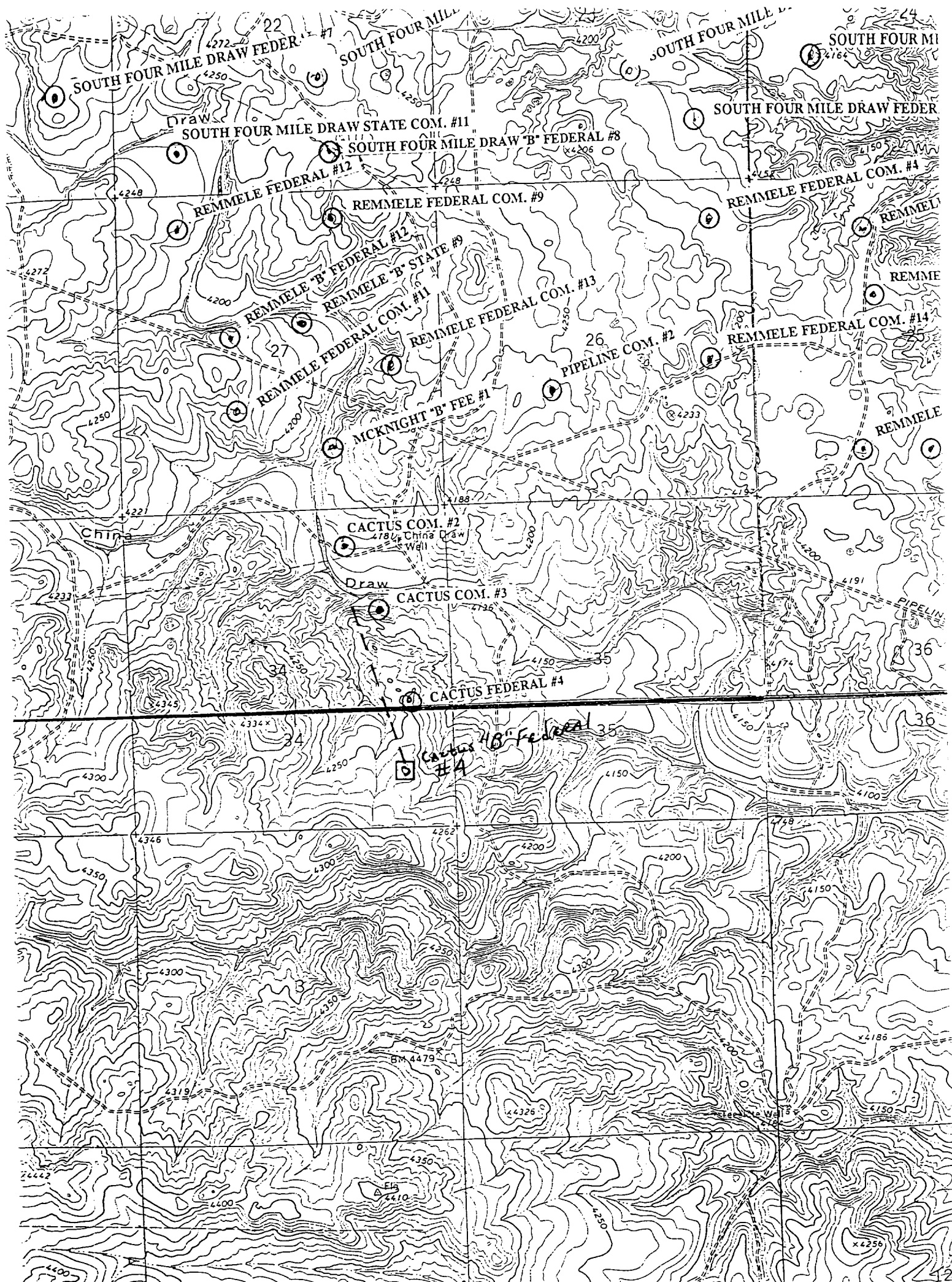
