Santa Fe Energy Resources, Inc. respectfully requests that the Authority to Drill the subject well be extended for one year. We plan to drill this well in 1995, the location has been constructed for several months.

We also propose to implement the following changes for the drilling of the captioned well:

1. We propose to set 13-3/8" 48.0 ppf casing in a 17-1/2" hole at 400', utilizing 400 sx of cement to circulate to the surface.
2. We propose to drill an 11" hole to app. 4100' (instead of the stated 12-1/4" hole).
3. We propose to test the 3-M BOP stack and manifold to 1500 psi. with a rig pump.
