Proposed perforations are: PC - 3240' - 3284' ; MV - 4956' - 5542' These perforations are in TVD.

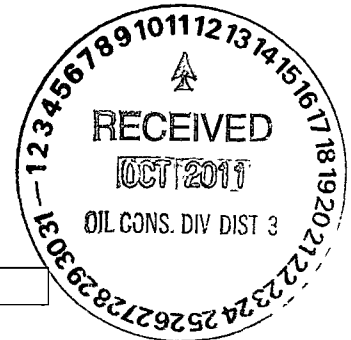
