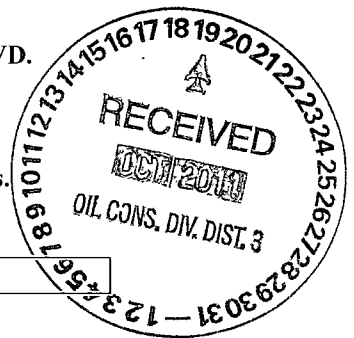
Proposed perforations are: MV - 3566' - 6121' ; DK - 7748' - 8031' These perforations are in TVD.
