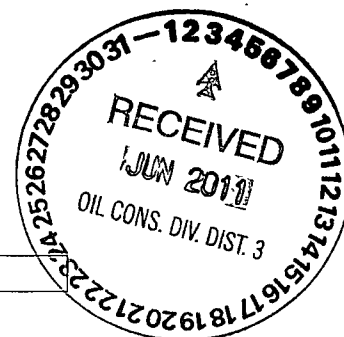
Proposed perforations are: MV - 3394' - 5914' ; DK - 7430' - 7695' These perforations are in TVD.
