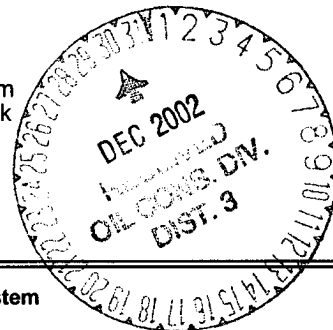

11/21/02 MIRU Key #63. Kill well w/2% KCL. ND WH & NU BOPs. PT-OK. COOH w/tubing. RIH w/CIBP & set @ 6400'. Load hole w/2% KCL & PT plug & casing to 500 psi. Good test. RU Blue Jet & BJ. Perforated MV interval @ 1 spf .34" holes @ 5851', 5849', 5774', 5770', 5755', 5751', 5748', 5746', 5737', 5735', 5728', 5726', 5723', 5668', 5666', 5641', 5634', 5632', 5628' = 19 holes.

Acidized perfs w/1500 gal 15% HCL. RU to frac. Pumped 146,400 gal 60 Quality N2 slickwater foam consisting of 52,600 gal of slickwater & 1.59 mm scf N2 & 150,070# 20/40 Brown sand. Flowed back on 1/4" and 1/2" chokes. RD flowback equipment. RIH w/2-3/8", 4.7# tubing. C/O to CIBP @ 6400' (PBD). PU & landed tubing @ 5830' w/"F" nipple set @ 5824'. ND BOP, NU WH. Pumped off expendable check. RD & released rig 11/29/02. Turned well over to production to flow the MV.
