Perforated MV @ 1 spf .34" holes - 5803', 5791', 5766', 5761', 5752', 5747', 5738', 5724', 5720', 5712', 5707', 5681', 5673', 5667', 5646', 5637', 5582', 5577', 5490', 5484', 5478', 5435' = 22 holes. Acidized perms w/1500 gal 15% HCl. RU to frac. Pumped 149,788 gal of 60 Quality N2 slickwater foam w/1.53 mmcf N2 & 145,900# 20/40 Brown sand. Flowed back on 1/4" and 1/2" chokes. RD flowback equipment. RIH w/mill & C/O fill to CIBP & 6500'. D/O CIBP. C/O to PBD @ 7980'. CoOH. RIH w/2-3/8", 4.7# tubing and set @ 7903' w/"F" nipple set @ 7897'. ND BOP, NU WH.
