11/8/02 RU Blue Jet & perforated liner @ 4 spf .75" holes - 3374'-88'; 3360'-68'; 3342'-54'; 128 holes. RD Blue Jet. RIH w/pump, & 2-3/8", 4.7# tubing. EOT set @ 8898' w/perforated sub sections @ 3374'-76' & 358-60' & "F" nipple set @ 3360'. ND BOP, NU rods. Test insert pump. Ran rods. RD & released rig 11/9/02. Turned well over to production to put back on line.
