Pumped a preflush of 20 bbls FW & 10 bbls FW w/dye ahead of 130 sx (171.6 cf - 30.6 bbl slurry) 50/50/STD/POZ cement w/2% gel, 5#/sx Gilsontite, 3% BWOC CaCl<sub>2</sub>, 1/2#/sx Flocele and 0.2% CFR-3. Released wiper plug and displaced plug w/18.8 bbls FW. Bumped plug @ 1007 hrs 3/3/03 w/460 psi. Circ. 47 sx cement to surface. Released Halliburton. WOC. NU head and BOP.
