Released wiper plug and displaced plug w/15.3 bbls FW. Bumped wiper plug @ 0824 hrs 3/21/0 w/400 psi. Circ. 15 bbls good cement to surface. RD Schlumberger. WOC. NU WH & BOP. PT blind rams, WH connections, casing & inner choke line valve w/200 psi for 2 minutes and 1175 psi for 30 mintues. Good test.
