Pumped a preflush of 30 bbls FW w/dye in the last 10 bbls. Pumped Lead - 375 sx (1091.3 cf - 194.4 bbl slurry) Standard cement w/3% Econolite, 10#/sx Gilsonite, & 1/2#/sx Flocele. Tail - 100 sx (133 cf - 23.7 bbl slurry) 50/50/STD POZ w/2% Gel, 5#/sx Gilsonite, 2% BWOC CaCl<sub>2</sub>, 1/4#/sx Flocele. Released plug & displaced w/124 bbls FW. Bumped plug 1250 psi. Circ. 20 bbls good cement to surface. RD Halliburton. Set slips and cut off casing. Installed trash cap. RD & released rig 0300 hrs 3/22/03. Will show casing PT on next report.
