Pumped a preflush of 18 bbls FW & 10 bbls FW w/dye. Then pumped 180 sx (242 cf - 43.1 bbl slurry) Standard 50/50/POZ w/2% gel, 5#/sx Gilsonite, 3% BWOC CaCl₂, 1/2#/sx Flocele and 0.2% CFR-3. Released plug and displaced w/14.25 bbls FW. Bumped plug w/450 psi. Circ. 16 bbls good cement to surface. WOC. NU BOP. PT casing, rams, & manifold to 600 psi for 30 mintues. Good test.
