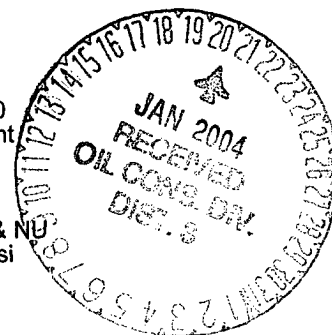

1/8/04 MIRU Key #49. Spud 12-1/4" hole @ 2030 hrs 1/8/04. Drilled to 244'. Circ. hole. RIH w/9-5/8", 32.3# H-40 casing and set @ 234'. RU Schlumberger to cement. Pumped a preflush of 30 bbls FW w/dye in last 10 bbls. Pumped 17.5 bbls cement. Ran out of cement. Circulated out cement with rig pump. Wait on cement bulk truck. Pumped another 15 bbls FW w/dye in last 10 bbls. Pumped 180 sx (208.8 cf - 37.2 bbls slurry) 150% excess - Class G cement w/2% CaCl2, .25#/sx Cello-phane, 2#/bbl cement. Released wiper plug and displaced plug w/15 bbls FW. Bumped plug w/420 psi. Circulated 7 bbls (39.3 cf) good cement to surface. RD Schlumberger. WOC. NU WH & NU BOP. PT - OK. WOC. PT blind rams, choke line valve, & casing to 300 psi for 3 minutes and 1000 psi for 30 minutes. Good test.
