

This sundry notice is to clarify the well name for the Richardson Operating Company proposed Federal 11-32 #4 well. The notice of staking was sent in by Permits West with the incorrect well name on 7-21-03. The Arch report sent in by La Plata Consultants dated 8-5-03 (Report LAC 2003-37a) also had the wrong name in the report. Both the Notice of Staking and the Arch report should have reflected the correct name for the well-being the Richardson Operating Company Federal 11-32 #4 well. The APD filed 8-4-03 has the correct name of the well. No other information has changed as of the date of this sundry. The well has not been drilled.
