Plans are to attempt to retrieve 2453' of fish left in the hole under a cement plug set above the liner top @ 3556' - 3606'. Hopefully we have perfected our technique of fishing 1-1/2" tubing and this will be possible. Plans are to drillout the cement plug, fish, then clean out to TD, run new tubing and return the well to production. Work is tentatively scheduled for summer 2001.
