Pumped a preflush of 28 bbls water w/dye in last 10 bbls. Pumped 370 sx (816 cf - 145.32 bbl slurry) Class G+ Chemical extender, 10#/sx Pheno-seal, 0.20% Antifoam. Tail - 210 sx (275.1 cf - 49 bbl slurry) 50/50/POZ Class G+, 2% Bentonite, 6#/sx Pheno-seal, 2% CaCl₂, .25#/sx Cellophane flakes, 1.5% Gilsonite extender, .010% Antifoam. Dropped plug and displaced w/141 bbls water. Bumped plug to 1500 psi @ 1507 hrs 4/22/04. Circ. 20 bbls good cement to surface. RD Schlumberger. WOC. Washed cement out of BOP. ND BOP, set slips and cut off casing. NU BOP. PT-OK. PT pipe rams, blind rams, choke manifold - OK. PT casing to 1800 ps for 30 minutes. Good test.
