Pumped a preflush of 30 bbls FW w/dye in last 10 bbls. Pumped Lead 435 sx (1135 cf - 202 bbl slurry) Class G cement w/3% extender, 0.25#/sx Cellephane, & 0.2% antifoam. Tail - 100 sx (127 cf - 22.5 bbl slurry) 50/50 Class G POZ w/2% gel, 5#/sx Gilsonite, 2% CaCl₂, 0.25#/sx Cellephone, & 0.2% antifoam. Released wiper plug and displaced w/20 bbls FW & 112.4 bbls mud. Bumped plug w/1440 psi @ 0710 hrs. Circ. 30 bbls good cement to surface. RD Schlumberger. Changed out rams to 4-1/2", ND BOP, set slips and cut off casing. Installed trash cap. RD & released rig @ 1430 hrs 4/26/04. Will show casing PT on next report.
