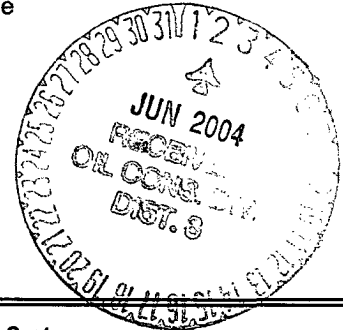

We submitted a previous sundry stating that this well would be plugged. The well was tested again in early May, 2004. The well produced about 10 mcf/d with no water. Subsequently, we discovered a method to build an inexpensive compressor that will allow this well to be produced. We are in the process of building this compressor now. This well will be placed on production within 90 days. We will comply with BLM/OCD rules concerning continued shut-in of this well for that period of time.
