RIH w/2-3/8", 4.7# tubing and set @ 3426'. RiH w/RWAC-Z pump & rods. Spaced out rods. Load tubing w/H2O. Test tubing to 1000 psi - OK. 5/28/04 TOH w/1 jt tbg. Re-landed tubing @ 3414' w/SN @ 3393'. ND BOP. RD & released rig 5/29/04.
