17. Describe Proposed or Completed Operations:

6-2-04

We request approval to recomplete this well in the South Blanco Tocito formation by the following procedure:

Rig up.

T. O. H. standing back 2 3/8" tubing.

Run wireline set retrievable bridge plug to 6900'.

Perforate Tocito zone, 6659' - 6645', with 4 shots per foot.

Frac with 20,000# 20/40 sand and N2 foam.

T. I. H. with 2 3/8" tubing with retrieving head to approximately 6660'.

Clean up and test Tocito zone.

Recover retrievable bridge plug from 6900', T. O. H.

T. I. H. with 2 3/8" production tubing.

Clean out to PBSD with air foam unit.

Land tubing on doughnut at approximately 7400'.

Rig down and move.

Estimated starting date, July 26, 2004.

No new surface will be disturbed, location area will be cleaned up following operations.

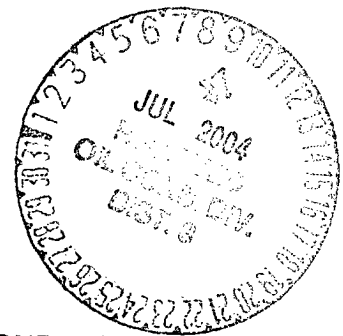
