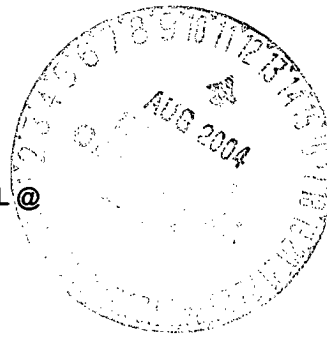

RIH w/9-1/2" underreamer & underreamed 6-1/4" hole to 9-1/2" from 2824' to 3210'. Circ. hole. TOOH w/underreamer. Ran initial pitot. Surged well naturally and with air & mist & foam for approx. 7 days. C/O to TD. RIH w/5-1/2", 15.5#, K-55 LT&C preperforated casing (12 jts)& set @ 3210' TOL @ 2797'. PBTD @ 3207'. Perforations from 2885' - 2906' and 2970' - 3035'; 3098' - 3120'. 7/30/04 RIH w/mill & M/O perf plugs. Circ. clean. RIH w/2-3/8", 4.7#, J-55 tubing (103 jts) and set @ 3160' w/SN @ 3140'. ND BOP, NU WH. R/D & released rig 7/30/04.
