Drilled 12-1/4" hole to 305'. On 5/19/2004, set 6 jts 9-5/8" 32.3# casing at 297'. Cemented with 175 sx (37 bbls) Class "B" cement w/ 1/4# Flocele and 2% CaCl2. Circulated 12 bbls to surface. Tested casing to 1500 psi.

Drilled 8-3/4" hole to 3600'. On 5/23/2004, set 80 jts 7" 23# casing at 3592'. Cemented with 475 sx (122 bbls) 50/50 Poz with 2% Gel, 0.2% Versaset, 0.1% Diacel. Foamed slurry with Nitrogen. Tailed in with 75 sx (19 bbls) same slurry without nitrogen. Circulated 30 bbls cement to surface. Tested casing to 1500 psi.

Drilled 6-1/4" hole to 8030'. On 5/27/2004, set 190 jts 4-1/2" 11.6# casing at 8025'. Cemented with 235 sx (61 bbls) 50/50 Poz with 2% Gel, 0.2% Versaset, 0.1% Diacel. Foamed slurry with Nitrogen. Tailed in with 450 sx (117 bbls) Class "B" w/ 3% Gel, 1.4% Halad-9, 0.1% CFR-3, 5# Gilsonite, and 1/4# Flocele. Circulated 20 bbls to surface. Tested casing to 4500 psi.
