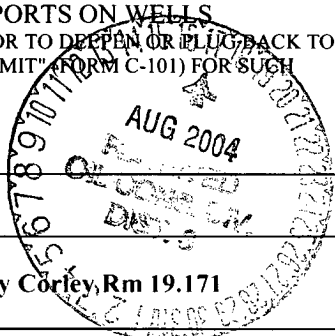

Surface commingling Blanco Mesaverde, Blanco S. Pictured Cliffs & Ortero Chacra production will consist of the Riddle F LS No. 3; and Basin Fruitland Coal production will be from the Riddle I No. 1. The production from each well will be metered prior to commingling (please note: production from the Riddle F LS No. 3 is currently being commingled downhole with production allocated based on the subtraction method - DHC-3175) then the commingled production will flow into through the separator where the liquids will be removed.
