Drilled 6 3/4" hole to 2590', and ran 4 1/2", 10.5#, J-55, ST&C Casing, landed @ 2576.21' KB (KB=5'0").

Cemented on 8/29/04. Lead cement pumped 277 sks 12.5# Class B Cement w/ 2% Sodium Metasilicate, plus 3 pps Gilsonite, plus 2 pps PHENOSEAL, plus .25#/sk cello flake, yield 2.09, volume 579 cu. ft. Tail with 55 sks 14.5# Class B Cement, plus 1% Bentonite gel, plus 2% CaCl2, plus 3 pps Gilsonite, plus .25#/sk cello flake, yield 1.40, volume 77 cu. ft.. We used centralizers on the first 3 joints in hole, and every +/- 400' thereafter. Used 2 turbolators, 1 at the base of the Ojo, and the other in the Ojo. Circulated 5 bbls of good cement to surface. Wait on cement +/- 17 hours.
