CHANGE OF PLANS

CBL's run on 10/22/04 and 10/25/04 show similar results. TOC is 100% bond at 2000' (the top depth run, and true TOC may be higher), though bond varies from 100% to 0% from TD to 2000'. We propose fracture stimulating the DK formation according to plan, as this zone is covered with 100% bond. We will proceed with our plan by flowing the DK for approx 90 days before returning to location to complete the MV interval. The MV interval will require cement remediation before its completion. Cement remediation is only planned in the MV interval because other gas bearing zones are either covered or separated by 100% bond.
