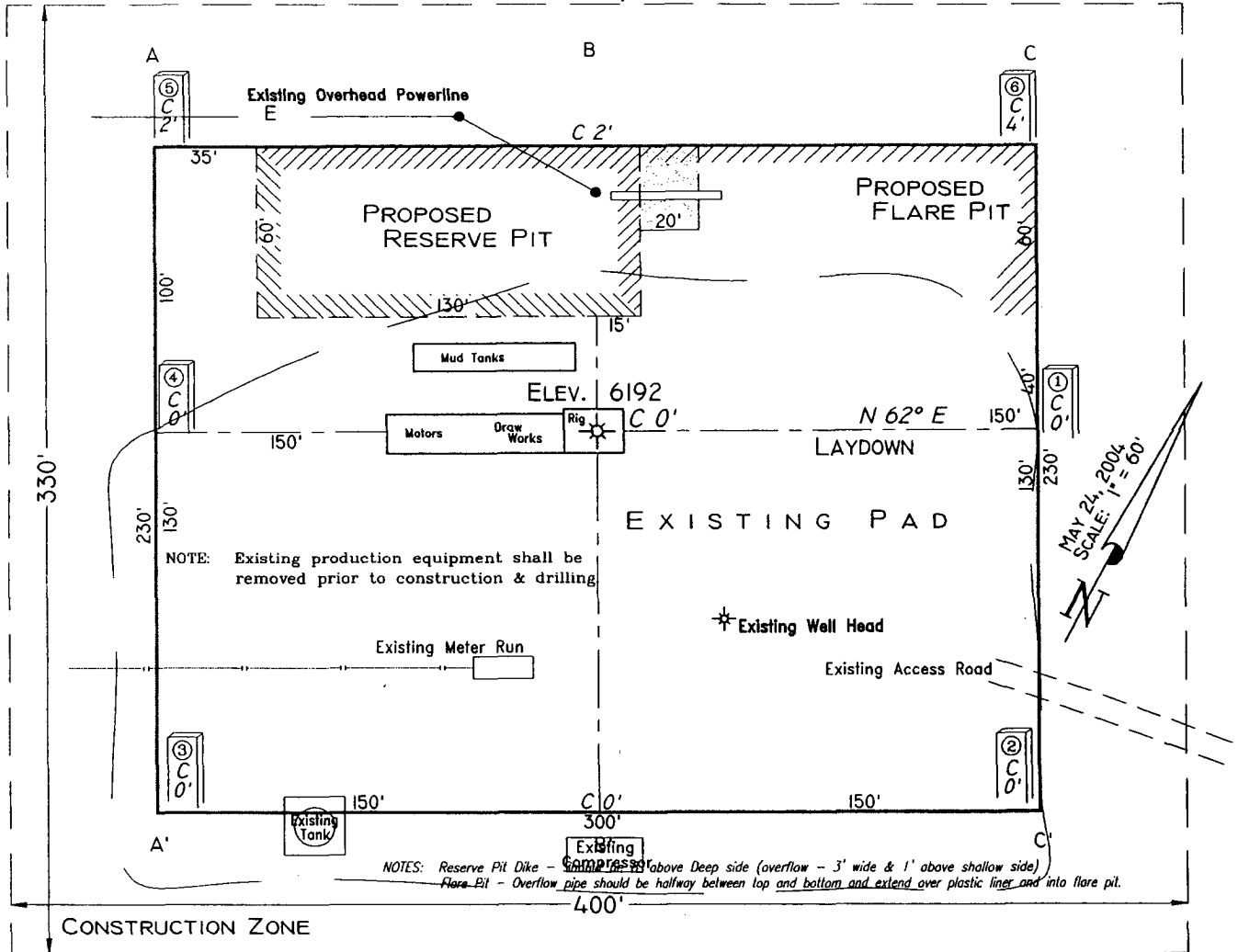

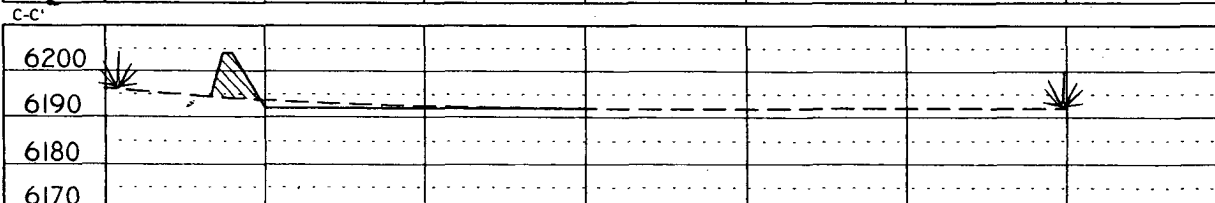
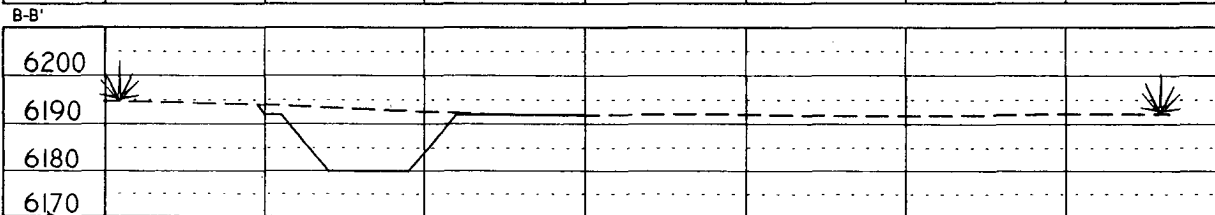
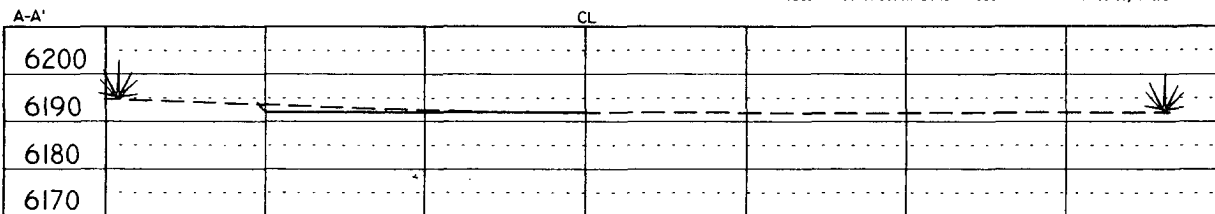
**PAD LAYOUT PLAN & PROFILE**
