Mixed & pumped plug #1 w/47 sx Type III cement (14.8 ppg) fr/1638' - surface. Pressure increased to 1200 psig. SD. WOC. Cut off WH. Installed dry marker w/15 sx Type III cement. Marvin Huntley w/BLM on location. RDMO A-Plus rig. Well is plugged & abandoned.
