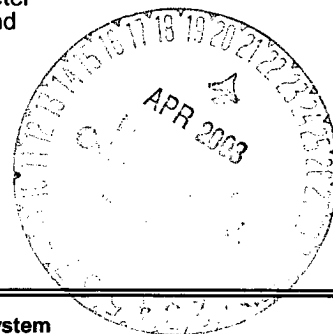

Reporting on the Dakota horizon will discontinue as of Jan 03 as it was plugged and abandoned.
