Drill to TD @ 980' on 3/4/03. Run 24 jts 4-1/2" 9.5# csg, set @ 968'. Cement w/50 sx 2% Lodense w/1/4# celloflake/sx. Tail w/60 sx Class "B" neat (172 cu ft total). Circ 8 bbls of cement.
