Pumped Lead - 400 sx (1044 cf - 185.9 bbls Class G w/3% D079 (Chemical Extender) 0.25#/sx D029 (Cello-flake), 0.05 GPS D047 (Antifoam Agent) & 0.2% D046 (all purpose anti-foam agent). Tail - pumped 105 sx J(127.6 cf - 23.7 bbl slurry) 50/50/G/POZ w/2% D020 (Bentonite), 2% S0001 (CaCl2), 5#/sx D024 (Gilsonite) 1/4#/sx D029 (Cello-flake) & 0.1% D046 (Antifoam agent). Released plug and displaced w/127.6 bbls FW. Bumped plug w/2000 psi @ 2041 hrs 4/7/03. Circ. 37 bbls good cement to surface. RD Schlumberger. ND BOP, set slips and cut off casing. Installed trash cap. Will show 7" casing test on next casing report.
