Drilled 12 1/4" hole to 307' on 09/10/04, set 8 jts of 9 5/8", H-40, ST&C, 32.3# casing at 297'. Cemented w/175 sx (36 bbls) "B" cement w/2% CaCl and 1/4# PSX Floseal. Circulated 13 bbls of cement to surface. Test casing to 1500 psi.

Drilled 8 3/4" hole to 3,689' on 9/14/04, set 87 jts of 7", J-55 LT&C, 23# casing at 3,657'. Cemented lead w/650 sx (172 bbls) 50/50 POZ w/3% Gel, 5# Gilonite, 1/4# Flocele, 1/10% CFR 3, 4/10% Halad 344 and tail w/75 sx (15 bbls) STD, 4/10% Halad 344. Circulated 15 bbls of cement to surface. Tested casing to 1500 psi.

Drilled 6 1/4" hole to 4,051' TMD. Underreamed hole to 9 1/2" from 3,660' to 4,054'. Utilized natural and air assisted surges to remove near wellbore material. No casing was run or cement pumped in this section of hole. If well conditons dictate, may run 5 1/2" liner at a later date. Landed 2 3/8" production tubing at 3,678'.
