Proposed perforations are: FC - 2416' - 2837' ; PC - 2838' - 3038' These perforations are in TVD.

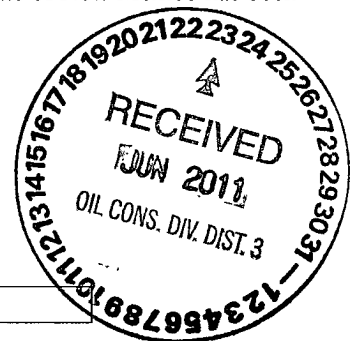
