This well was first delivered on 6/20/2011 and produced natural gas and entrained hydrocarbons.

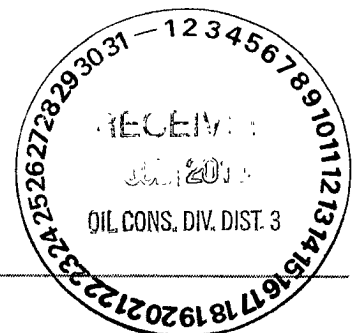
