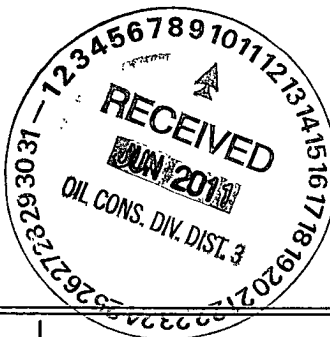

Cement with 133 sks Type V, 2% CACL2, 1/4#/sk floccle (159.6 cu. ft.). Plug down @ 5:00 pm on 5/25/11. Circulated 10 bbls of good cement to surface. RD Halliburton. WOC. NU BOP. Pressure test blind rams, pipe rams, all valves on choke manifold, kill line, floor and kelly valves - 250#, low - 5 minutes and 2000#, high - 15 minutes - ok. Witnessed by Rod Velarde - Jicarilla BLM. Test 9.625" casing to 750 psi for 30 minutes - ok.
