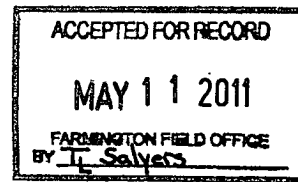
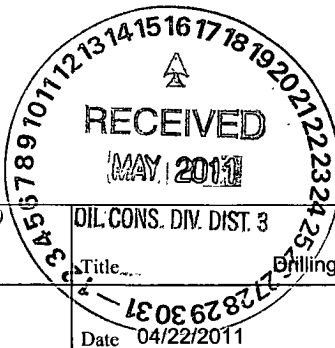

4-15-11; Perforate 7553' to 7568' with 31 0.40" holes. 4-16-11; Acidize with 3000 gal 7 1/2% HCl acid.

4-16-11; Perforate 7469' to 7481' with 48 0.40" holes, acidized with 2000 gal 7 1/2% HCl acid.

4-22-11; Fracture treated zones with 18200# 20/40 mesh sand and 893 bbl CO2 foam (foam made up with 89 T CO2 and 410 bbl 30# gelled water).
