Spud 12-1/4" hole on 6-27-11. Drilled to 132'. Run 8-5/8" 24# J-55 casing. Land @ 128', float collar @ 91'. Cement w/120 sx Type III cement w/2% CaCl2 & 1/4# celloflake/sx (157 cu ft total slurry). Displaced 5.7 bbbs water. Circulated 7 bbbs cement. NU BOP. Pressure test blind rams, pipe rams, choke manifold, and casing at 250 psi minimum and 1500 psi maximum. Pressure test 8-5/8" surface casing at 600 psi. All held with no leaks.
