Cement with 105 sks Type V, 2% CaCl2, 1/4#/sk floccle (126 cu.ft.) Circulate 3 bbls cement to surface. Plug down @ 11:15 pm on 06/27/11. WOC. RD Halliburton. NU BOP. Test casing 750 psi for 30 minutes - ok. Tested BOP 250# low - 15 minutes and 2000# high - 15 minutes ok.
