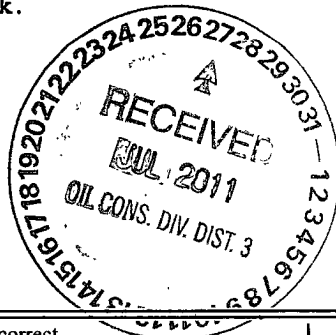

7/17/11 Drill hole 8.75" hole to 4335'. Run 101 jts. 7" 23# K-55 LT&C casing, set at 4335'. Two stage cement job. 1st stage - cement with 80 sks of PRB-II, 3#/sk Kol-seal, 1/8#/sk poly-e-flake, .3% D-air 3000, .5% FE-2 (145.6 cf). Plug down at 7:30 am on 7/17/11. Circulate 8 bbls of cement to surface. Circulated 4 hours between stages. 2nd stage - cement with 430 sks of PRB-II, 3#/sk Kol-seal, 1/8 #/sk poly-e-flake, .3% D-air 3000, .5% FE-2 (1023.40 cf) tailed with 50 sks Class G cement (57.50 cf) Plug down at 1:00 pm on 7/17/11. Circulate 80 bbls of cement to surface. WOC. NU BOP. Pressure test casing to 2000 psi - 30 minutes - ok.
