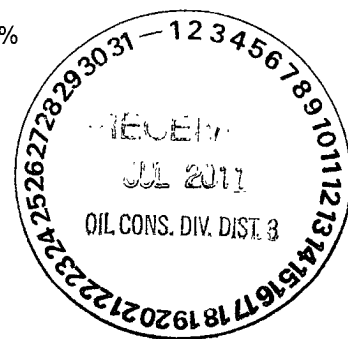

Tail w/70 sx Type III cement w/1# sx CaCl₂, 1/4# celloflake/sx, 0.2% FL-52 (331 cu ft total slurry). Displace w/27.8 bbls cement. Circulate 17 bbls cement. Released on 06/16/11. ✓
